Dr. T.S. Bisht, IPS, President, nominated Dr. Tejraj Singh of Rajasthan as Executive Director of TKFI.


Dr. T.S. Bisht, IPS, President, nominated Mr. M.R. Dinesh Kumar as Organizing Secretary of TKFI.




