Anti-Doping Committee (2025-29)

Tennikoit Federation of India (TKFI)

Article 24.1.VI: Functions of the Sub-Committees (Ethics Committee)

1. Purpose and Mandate:

The Committee is established to ensure a "Dope-Free" environment for the sport of Tennikoit in India. Its primary mandate is to:

- Implement the **National Anti-Doping Agency (NADA) India** and the **WADA Code**.
- Educate athletes and Athlete Support Personnel (ASP) on prohibited substances.
- Facilitate sample collection during National and Zonal Championships.
- Coordinate with NADA for Registered Testing Pool (RTP) and "Whereabouts" filing.

2. Composition of the Committee:

As per MYAS and NADA requirements, the committee must be composed of domain experts independent of the day-to-day administrative politics of the federation.

Designation	Qualifications/Role
Chairman	Dr Siddappa Dindawar from Karnataka has 25+ years of experience in Medicine.
Vice-Chairman	ADV. Smt. Namita Chile, Balaghat, MP, Advocate with experience in Law with 10+ experience or Regulatory Compliance.
Member 1	Mr Rahul M. Shangrapawar from Maharashtra is a retired athlete and International Tennikoit player, who played in the 1st World Cup and 2nd World Cup.
Member 2	Mr B. Murali from Tamilnadu, Indian Team Coach and Technical Expert, is more familiar with international Tennikoit regulations.
Convener	Mr M.R. Dineshkumar from Pondicherry- Secretary-General, being the convener of the committee, as TKFI representative (liaison between Committee and Executive Body).

A. Education and Awareness

- Conducting mandatory **Anti-Doping Awareness Programmes (ADAP)** before National Championships.
- Ensuring all athletes complete the WADA **ADeL** (Anti-Doping e-Learning) modules.
- Distributing the latest **WADA Prohibited List** (updated annually).

B. Therapeutic Use Exemption (TUE)

- Assisting athletes with medical conditions in filing TUE applications to NADA for the use of necessary medications that may contain prohibited substances.

C. Testing and Investigation

- Liaising with NADA to provide a "Doping Control Station" (DCS) at venues.
- Ensuring "Chaperones" are trained to notify athletes selected for testing.
- Reporting any suspicious activities or "trafficking" of substances within the sport.

4. Disqualification Criteria

In accordance with the **National Sports Governance Rules, 2025**, no person shall be a member of the committee if they:

- Have been convicted of a criminal offense.
- Have a history of an **Anti-Doping Rule Violation (ADRV)**.
- Holds a conflict of interest with a pharmaceutical or supplement company.

5. Reporting Protocol

The TFI Anti-Doping Committee must submit a **Quarterly Compliance Report** to:

- NADA India** (detailing education activities and testing assistance).
- MYAS** (as part of the annual recognition renewal for NSFs).

Important Note: Under the 2025 Amendment to the National Anti-Doping Act, the Federation must ensure complete operational independence of the committee from the Executive Body during investigations.
