Referee Examination

A Referee Examination will be conducted during the camp.

Since it is very difficult to conduct Referee Examinations during National Championships due to time constraints, this camp provides a proper and structured platform for assessment.

- Referee Examination aspirants may be sent as **Coaches of the concerned State**.
- The **Referees Board will initiate and conduct the complete examination process**, including theory and practical evaluation.
- Do not send experienced referees. Encourage new and aspiring referees.
- If no suitable referee is available, the State Unit may send two coaches instead.

Qualification for Coaches

The Coach must have been a Tennikoit player at any level (District/State/National).

Programme Structure

- Practical Court Sessions
- Theory Classes
- Referee Examination
- Interactive Sessions on Rules and Innovations

Suggestions relating to rules, technical improvements and innovative development of the game are invited.

Entry Fee

- ₹1000/- per head
- Referees are exempted from paying the entry fee.

Boarding & Lodging

Boarding and lodging will be arranged from the reporting time. Facilities may differ from place to place and time to time. Participants shall not expect maximum amenities and are requested to cooperate.
